

## Format requirements for preparing papers

### **TITLE OF THE PAPER (NOT MORE THAN 3 LINES). FONT 12 PT TIMES NEW ROMAN, BOLD, CAPITAL LETTERS**

<sup>1</sup> Name of the university or organization, represented by the first author, specify the country  
*Your email address. Font Times New Roman 12pt, italic*

<sup>2</sup> Name of the institution or organization, represented by the second author, specify the country  
*Your email address. Font Times New Roman 12pt, italic*

The paper content shall not exceed **5 pages of A4 format**. Font Times New Roman 12pt, margins: top, bottom, side - 2.5 cm, line spacing - 1, paragraph indention - 1 cm. Pages must be numbered at the bottom. Width alignment of the text. Manual transfer is not allowed in the text.

Paper e-file should be named as "author.doc", where the "author" implies the author's family name, who would be attending the Congress, **written in Latin letters**, for instance, Petrov.doc. Papers should be saved in Microsoft Word format.

### **SUMMARY**

Summary to the paper article is intended to serve as an independent source of information; it is the basic and most widely read part of the paper. It should contain within 50 to 250 words.

An abstract includes the characteristics of the main topic, problems, objectives and results. The summary indicates what new this paper brings about in comparison with the other papers related in subject matter and purpose. The authors are asked to attend to the fact that it is required to take responsible and careful approach making summaries.

### **KEYWORDS**

5-7 keywords or word phrases shall be separated by a comma.

The keywords are words or phrases of the paper bearing significant meaning in terms of information retrieval.

### **FORMULA**

Formulas should be numbered consecutively on the right margin in parentheses. They should be typed using Microsoft Word formulas editor or MathType program (font Times New Roman 12pt).

There must be explanations to all the references (legend) in certain formulas.

### **ILLUSTRATIONS**

Tables, figures, drawings, charts and graphs should be within acceptable margins.

Captions in the figures should be clear, well readable. Illustrations must be entered in the right parts of the text using computer graphics in a raster format, with tif, bmp or jpg extension. The numerical symbols in figures should be of direct tracings, except designation of curves. Each drawing, diagram, graph should be of a single entity, it should allow scaling and changes of the positioning without violation of the image integrity.

It is required to clarify all symbols and abbreviations used in the figure. Center alignment of the page, without indentation.
